

DAYS AT HARVARD END.

Prof. W. W. Goodwin Bade Farewell to Friends.

The Noted Greek Scholar Guest at a Banquet.

Presented with Magnificent Silver Loving Bowl.

William W. Goodwin, professor of Greek at Harvard Coffege, after a ca-teer extending over nearly half a century, which has placed him at the head among Greek scholars of this country, bade farewell to his colleagues and friends at Harvard at a banquet given in his honor by graduates of Harvard College in the magnificent ballroom of the Hotel Somerset, this city, last night One hundred and thirty odd covers were laid and not a chair was vacant. The main table was profusely deco-rated with flowers, and the crimson decorations of the ballroom, mingled*

with the white and gold, were particuwith the white and gold, were particularly appropriate to the occasion. Bishop Lawrence presided. On his right was Prof. Goodwin, and on the bishop's left, facing the professor, was President Ellot of Harvard. A beautiful bunch of crimson American Beauty roses occupied the centre of the table, and on the front cover of the menu was a splendid half-tone picture of Prof. Goodwin.

Lawrence called the company to order, and, on behalf of the guests assembled, presented Prof. Goodwin with a magnificent chased silver bowl, bearing the following inscription:

WILLIAM WATSON GOODWIN,
5 June, 1901.
With the Lore of Pupils, Colleagues and
Lifelong Friends.

Bishop Lawrence, in presenting the bowl, spoke of the regret which Prof. Goodwin's retirement from the position he had so long and honorably filled would cause his friends and colleagues at Harvard, and referred to the professor as a man who had won not only the highest honor from his alma mater but from Columbia, Cambridge, Oxford and Edinburgh.

"He was," said the bishop, "not only an originator, but an interpreter of the works of the greatest men of ancient times, and what nobler work can man do than interpret the sublime work of the arcient manters for generations still unborn?

"The professor." he went on, "was known throughout his long service as a man of marked individuality of character, and we meet here tonight not only to say homage to a scholar, but to a man who has given us the highest type of a relined scholar and a gentleman."
